Mission: To pursue European interests within the Blockchain/DLT Standardisation landscape

OBJECTIVES

Obj.1: Establish a facility dedicated to support EU experts contributing to blockchain standardisation efforts, in alignment with the Rolling Plan for ICT Standardisation.

Obj.2: Liaise with EBP initiatives and European SDOs in the area of blockchain/DLT standardisation.

Obj.3: Map the sector and engage all Stakeholder Groups promoting the EU standardisation initiatives, also via organisation of international events.

Obj.4: Contributing to implementation of European Values and sustainability of the EBSI.

Selection and Support Procedure - **€ 300,000** earmarked to support **40+ European experts** contributing to Blockchain/DLT Standardisation efforts, in line with the Rolling Plan for ICT Standardisation.



Contribution to **100+ Standardisation documents** (Deliverables/Technical Reports/Specifications) by the Experts funded by SEEBLOCKS.eu.



Establishment of a **Permanent Task Force** (PTF) in collaboration with EU Blockchain players with a coordinated approach on the EU & International scene.



Set-up of Technical Working Group of experts to deliver a "**Landscape and Gap analysis Report**" on Blockchain/DLT Standardisation.

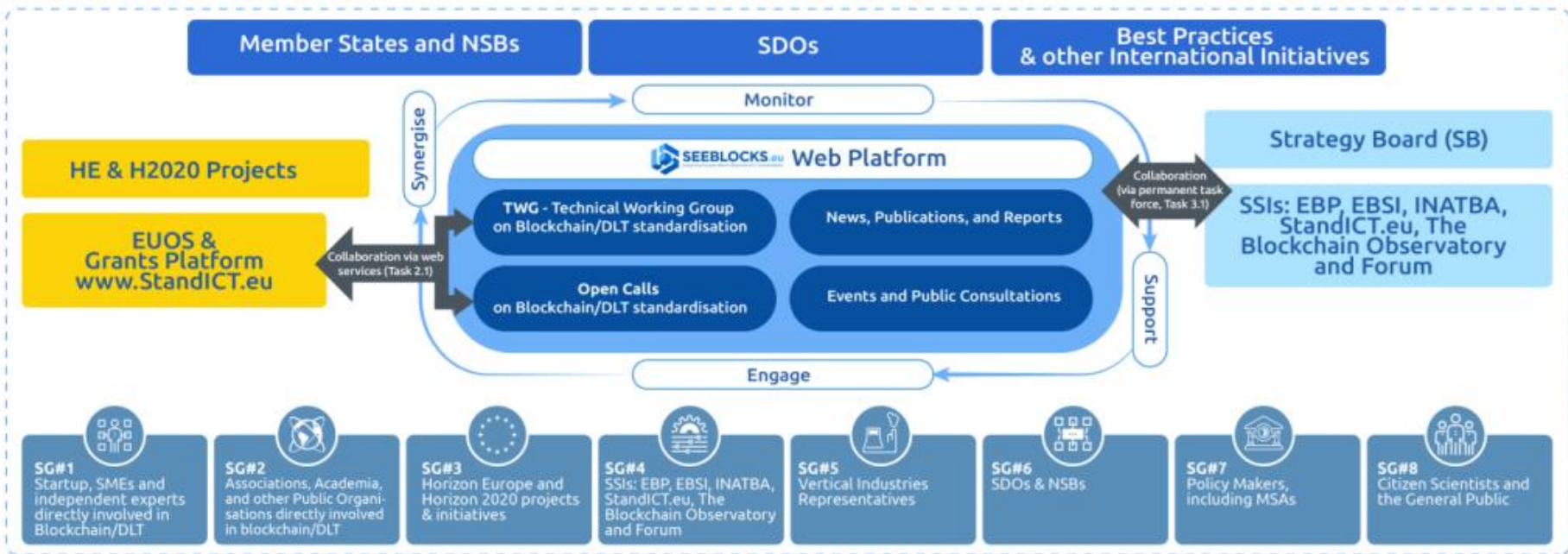

- BLOCKSTAND and SEEBLOCKS.eu to set periodical meetings + a “hot line” via email to discuss the following:
 - Joint events: A first, joint webinar is being organized with a target date at the end of July (see separate slide).
